

TERMS & CONDITIONS

You can collaborate with the role of Speaker, to promote your experience and knowledge through CODEMOTION channels.

The Speaker will carry out the intervention free of charge and without any subordination to CODEMOTION.

CODEMOTION reserves the right to change the date or cancel the event, promptly notifying the Speaker by email, telephone or IM application.

It is understood that in case of cancellation, for whatever reason, of the event no compensation or indemnity, for whatever reason, will be granted to the Speaker, without prejudice to any reimbursement of travel expenses incurred before the date of the aforesaid communication.

If the Speaker is no longer available to attend the event, he/she must provide written notice to the organizers at least 15 days before the date of the event.

The Speaker may not be replaced by another person unless authorized by CODEMOTION which, in its sole discretion, may evaluate the request for replacement with another speaker whose name and curriculum vitae must be provided.

During the speaking activity, the Speaker undertakes not to promote other initiatives from the event and or Codemotion brand, and not to promote job positions, except made for speakers whose companies are sponsors of the conference with agreements that include benefits related to recruiting.

With regard to online events, by accepting these conditions, the Speaker authorizes CODEMOTION - and any other person appointed by it - to record his/her speech or use sent speech videos, these conditions are necessary for the participation/organizations in the event itself.

During the offline conference some Talks could be recorded, for this purpose the Speaker, by accepting these conditions, authorizes CODEMOTION - and any other person appointed by it - to record his/her speech. Those who do NOT wish to give their consent to the video recordings during offline conference may express their NON CONSENT providing prior notice to CODEMOTION.

The Speaker also authorizes CODEMOTION and/or any of its assignees, to publish in any format on all CODEMOTION channels, video footage of his/her speech and the contents of the same. The licence thus granted is intended to be of indefinite duration, not revocable and without geographical limits. The video recording of the intervention, while maintaining consistency with the original content expressed may be subject to editing activities, such as extractions of clips from the recordings exclusively for public use, by CODEMOTION and its assignees.

The Speaker guarantees to be exclusive owner of all intellectual property rights on the contents of the intervention or, in any case, to have acquired the right to use them within the intervention and for their subsequent use by CODEMOTION.

The Speaker will be responsible in relation to what has been done and/or stated during the speech, to relieve CODEMOTION from any action or claim that may, in relation to this brought or made by third parties, undertaking, in this context, to hold CODEMOTION harmless of any such disputes and/or claims from any expense or economic prejudice that may arise, including the costs of litigation.



The Parties agree and mutually acknowledge that any dispute related to this assignment shall be the exclusive jurisdiction of the Court of Rome.
